In the identified area, the current year population is 115,857. In 2010, the Census count in the area was 98,898. The rate of change since 2010 was 1.73% annually. The five-year projection for the population in the area is 126,310 representing a change of 1.74% annually from 2019 to 2024. Currently, the population is 49.6% male and 50.4% female.

Currently, 58.4% of the 46,799 housing units in the area are owner occupied; 37.5%, renter occupied; and 4.1% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 40,474 housing units in the area - 61.3% owner occupied, 33.4% renter occupied, and 5.3% vacant. The annual rate of change in housing units since 2010 is 6.67%. Median home value in the area is \$194,084, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 1.97% annually to \$214,015.
