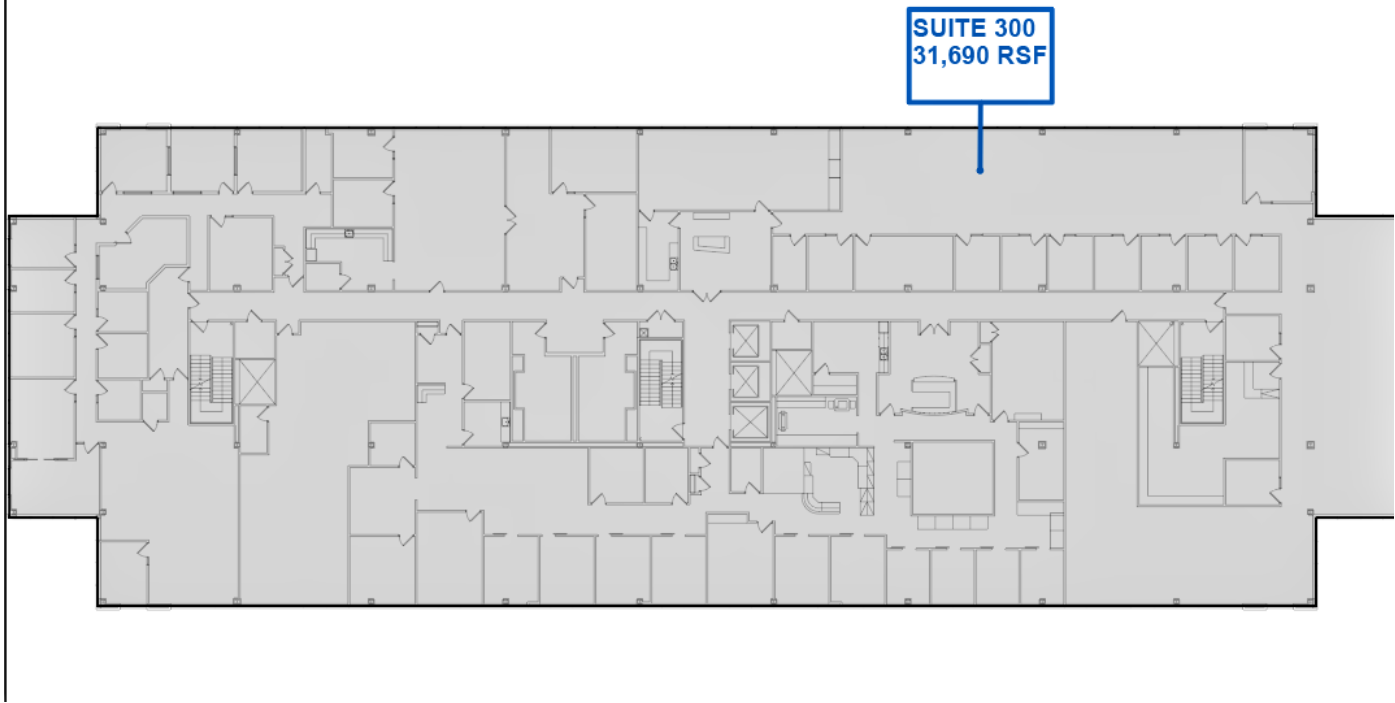
SECOND FLOOR PLAN

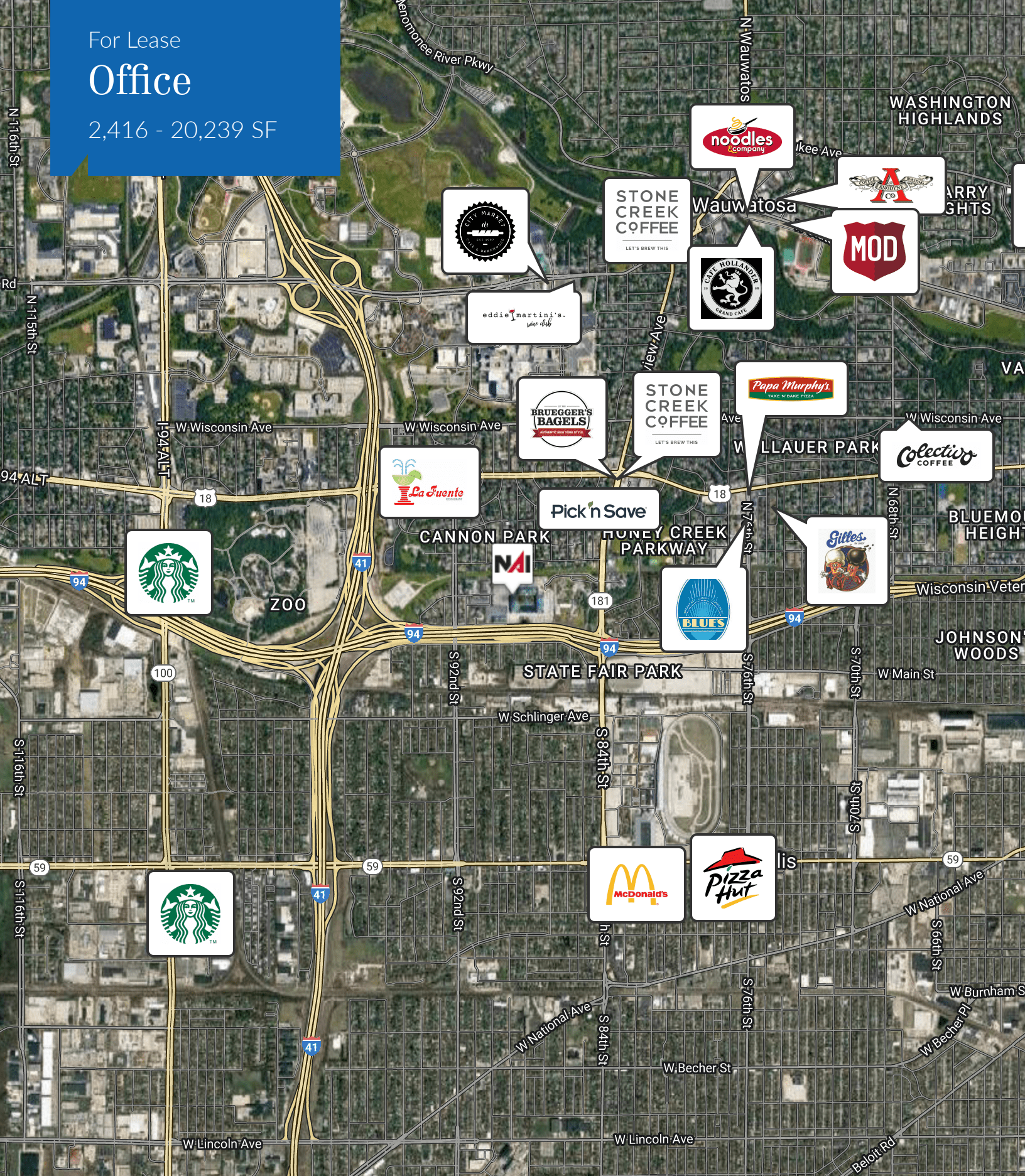
