The former Sand Spring restaurant (previously Homestead Inn) is a beautifully renovated 2,110 square foot building with seating for 70 in the dining rooms, bar area, and fireplace seating area. Kitchen features efficient design with walk-in coolers and freezers, beer coolers, and dry storage. Destination location approximately 0.5 mile from Route 390. Industrial zoning permits additional uses such as automotive sales, printing shop, and residence. The 0.86-acre vacant lot across Sand Spring Road is also included. Aggressively priced for quick liquidation. Monroe County restaurant liquor license not included but also available.

#### **LOCATION OVERVIEW**

Cresco is a village in Barrett Township, Monroe County in northeastern Pennsylvania. Cresco is located in the Pocono Mountains, with Callie's Pretzel Factory and Callie's Candy Kitchen being the town's most popular tourist attractions. Antique shops, hiking, horseback riding, fishing, and camping also draw in visitors. Cresco is home to mainly mom and pop stores. These include Lewis' Supermarket, Mick Motors, Price's Lumber and General Store (now affiliated with Steele's True Value Hardware), Basso Italiana, Kasa's Pizza and a number of antique shops. There is a CVS Pharmacy and Family Dollar located off of Route 390 in the center of town. Weiler Corporation and J.A. Reinhardt Manufacturing are two manufacturing companies and the largest employers in town. Two Poconos resort communities, Buck Hill Falls and Skytop, are located within the township. It is located 38 miles from Scranton and 48 miles from Wilkes-Barre. There is one privately owned, public-use airport in Barrett Township called the Flying Dollar Airport.














