In the identified area, the current year population is 126,116. In 2010, the Census count in the area was 111,913. The rate of change since 2010 was 1.17% annually. The five-year projection for the population in the area is 135,193 representing a change of 1.40% annually from 2020 to 2025. Currently, the population is 48.0% male and 52.0% female.

Median Age

The median age in this area is 35.0, compared to U.S. median age of 38.5.

Currently, 69.1% of the 52,808 housing units in the area are owner occupied; 25.6%, renter occupied; and 5.2% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 47,182 housing units in the area - 71.1% owner occupied, 23.1% renter occupied, and 5.8% vacant. The annual rate of change in housing units since 2010 is 5.13%. Median home value in the area is \$284,909, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 2.06% annually to \$315,412.
