

Property Overview

Located in the business-friendly City of San Fernando, near the intersection of Interstate 5, 118, 405, and 210 Freeways, 520, 540 550, 558 & 560 Library Street is a portfolio of three (3) free-standing industrial buildings totaling 29,400 square feet and situated on two (2) parcels totaling 59,941 square feet. The buildings provide 14' – 16' interior warehouse clearance height and ground level loading positions with 12' x 12' roll up doors. The building also features various amounts of office space, 3 phase power, fenced yards, ordinary fire hazard sprinklers and carry a City of San Fernando M1 industrial zoning designation allowing for a multitude of industrial applications.

520, 540 & 550 LIBRARY STREET are two 10,000 SF buildings, for a total of 20,000 SF, on one (1) parcel (APN 2519-025-009).






