

This unique property has boat yard service and repair operations currently being conducted on site and is uniquely positioned to accommodate the ongoing demand for vessel haul, launch, storage, commissioning, boat club, sales and services. Its heavy industrial zoning classification opens the door for additional uses and opportunities that are available for those who may have alternative needs for ingress and egress to Harsens island. Most of the property is paved with load-bearing concrete and steel buildings which are in very good condition. Sheet pile seawalls are utilized in most high volume areas (such as the Travelift well and in certain upland areas where a necessary retaining wall was installed. There is also a large previously designed and partially constructed well inside the northernmost storage building where 40' steel sheet pile was driven in preparation for excavation to create an approximately 150' long and 45' wide deep-water berth. The well is capped and covered in poured concrete (visible on the floor) but can be excavated to create a massive undercover (or open if the building is removed) slip for commercial boats, barges or large yachts.

Harsens Island is a spectacular and unique venue that is growing rapidly while retaining its rich history and its charm. Currently, all traffic on and off the island uses a continuous ferry that provides a swift and professional service. The island's proximity to Lake St. Clair and all of the extraordinary boating activity and clientele is sure to provide a strong and enduring venue for marine industry related activities and services. 






