COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4 OF SAID SECTION; THENCE ALONG THE CENTERLINE OF FAIRWAY AVENUE RUN NORTH 00°01'29" WEST, A DISTANCE OF 72.85 FEET; THENCE DEPARTING SAID CENTERLINE RUN IN PERPENDICULAR LINE TO SAID CENTERLINE NORTH 88'54'06" WEST, A DISTANCE OF 40.00 FEET TO A POINT ON THE NORTH RIGHT OF WAY LINE OF HIGHWAY 92/STATE ROAD 600-EAST MEMORIAL BOULEVARD BEING A POINT ON A CURVE TO THE RIGHT; THENCE ALONG SAID NORTH RIGHT OF WAY LINE RUN THE FOLLOWING TWO (2) COURSES AND DISTANCES: BEING A POINT ON A CURVE TO THE RIGHT, HAVING A RADIUS OF 11320.70 FEET AND A CENTRAL ANGLE OF 03'50'21", WHICH BEARS NORTH 87'06'47" WEST AND A CHORD DISTANCE OF 758.41 FEET; (1) THENCE RUN WESTERLY ALONG SAID ARC A DISTANCE OF 758.56 FEET; (2) THENCE NORTH 85"12'16" WEST, A DISTANCE OF 783.19 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE ALONG SAID NORTH RIGHT OF WAY LINE, RUN THE FOLLOWING TWO (2) COURSES AND DISTANCES (1) NORTH 8512'16" WEST, A DISTANCE OF 228.64 FEET TO A POINT OF CURVE TO THE RIGHT HAVING A RADIUS OF 2,865.24 FEET AND A CENTRAL ANGLE OF 02'38'43", WHICH BEARS NORTH 83'52'55" WEST AND A CHORD DISTANCE OF 132.27 FEET; (2) THENCE RUN WESTERLY ALONG THE ARC A DISTANCE OF 132.28 FEET; THENCE DEPARTING SAID NORTH RIGHT OF WAY LINE, RUN THE FOLLOWING THREE COURSES AND DISTANCES (1) NORTH 021239" EAST, A DISTANCE OF 122.34 FEET TO A POINT OF A NON TANGENT CURVE TO THE RIGHT, HAVING A RADIUS OF 533.13 FEET AND A CENTRAL ANGLE 13'08'42" WHICH BEARS NORTH 12'07'09" EAST AND CHORD DISTANCE OF 122.04 FEET, (2) THENCE RUN NORTHERLY ALONG THE ARC A DISTANCE OF 122.31 FEET TO A POINT OF COMPOUND CURVE TO THE RIGHT HAVING A RADIUS OF 465.00 FEET AND A CENTRAL ANGLE OF 04.58'09", WHICH BEARS NORTH 2110'35" EAST AND CHORD DISTANCE OF 40.32 FEET; (3) THENCE RUN NORTHERLY ALONG THE ARC A DISTANCE OF 40.33 FEET: THENCE DEPARTING SAID EAST RIGHT OF WAY LINE RUN SOUTH 85"12'16" EAST, A DISTANCE OF 341.46 FEET TO A POINT ON THE WEST RIGHT OF WAY LINE OF HOUR GLASS ROAD; THENCE ALONG SAID WEST RIGHT OF WAY LINE RUN THE FOLLOWING TWO (2) COURSES AND DISTANCES: (1) SOUTH 04'47'44" WEST, A DISTANCE OF 77.16 FEET TO A POINT OF A NON TANGENT CURVE TO THE LEFT, HAVING A RADIUS OF 75.00 FEET AND A CENTRAL ANGLE 41'12'24" WHICH BEARS SOUTH 15'48'27" EAST AND CHORD DISTANCE OF 52.78 FEET, (2) THENCE RUN SOUTHERLY ALONG THE ARC A DISTANCE OF 53.94 FEET; THENCE DEPARTING SAID WEST RIGHT OF WAY LINE RUN SOUTH 49'42'55" WEST, A DISTANCE OF 29.14 FEET; THENCE SOUTH 04'47'44" WEST, A DISTANCE OF 137.80 FEET TO THE POINT OF BEGINNING.
