



This Dollar General is located on the Russell Parkway – 1.6 miles east of Interstate I-75 (Exit 144). There are 29,000 residents within 3 miles of the store location. Warner Robins is home to Robins AFB; the home of the Air Force Materiel Command's Air Logistics Complex which is the worldwide manager for a wide range of aircraft, engines, missiles, software, avionics and accessories components. There are multiple residential subdivisions in the area and other retailers include Buc-ees "mega" Convenience Store and Walmart Neighborhood grocery store.



The city is the main component of the Warner Robins Metropolitan Statistical Area, including the entirety of Houston, Peach, and Pulaski counties, which had a census population of 201,469 in 2020; it, in turn, is a component of a larger trade area, the Macon–Warner Robins–Fort Valley Combined Statistical Area, with an estimated 2018 population of 423,572.




Population by Age




Population by Age






2021 Household Income
