Oslo Road/I-95 interchange is estimated to be completed in December of 2026. Property is located opposite the Winn Dixie market center and proximate to the Publix market center at nearby Oslo Rd and 43rd Avenue. The property is configured as three 1.62 acre Lots totaling 4.86 gross acres that includes track C (.84 acres of upland preserve). Upland preserve includes required 25' of landscape buffer easement. Site Plan flexibility to adjust Lot size. Lot lines not final. Each lot has approximately 231' +/- feet of road frontage on 27th Avenue (Emerson) with 253' +/- feet of depth. There is a common 75' cross access and public utility easement on the west side of properties along 27th Ave extending to Oslo Road through the Dollar General and Cumberland Farm store properties. Utilities are available onsite. Total 4.86 acre development site (4.02 net acres) with Limited Commercial (CL) zoning. Join many other national retailers capitalizing on area growth.





I-95 and Oslo Road Interchange and Widening Roadway Project



PROJECT IMPROVEMENTS

- New interchange with partial clover leaf ramps at I-95 and Oslo Road.
- Widening Oslo Road from a two-lane to fourlane divided roadway from west of I-95 to SW 58th Avenue.
- Interchange ramp lighting.
- Replacement of existing Oslo Road bridge over I-95.
- New signalized intersection at Oslo Road and 66th Avenue SW.
- Roadway Improvements on 74th Avenue, 66th Avenue and 58th Avenue.
- · Realignment of 82nd Avenue at Oslo Road.
- Elimination of the 86th Avenue connection to Oslo Road.
- New construction of 13th Street SW connecting 86th Avenue SW and 90th Avenue.
- Extension of south limit of noise wall on I-95.
- Replacement of county sanitary, water and raw water mains.
- Other improvements include drainage, ponds to accommodate roadway stormwater and flood compensation, signing, signalization and Intelligent Transportation System (ITS).

CONSTRUCTION IMPACTS

- All lanes will remain open during construction.
- Access to businesses and private properties will be provided at all times.

CONSTRUCTION INFORMATION

- Project Letting: March 29, 2023
- Construction Begins: Summer 2023
- Anticipated Completion: December 2026
- Construction Cost Estimate: \$85.4 Million


