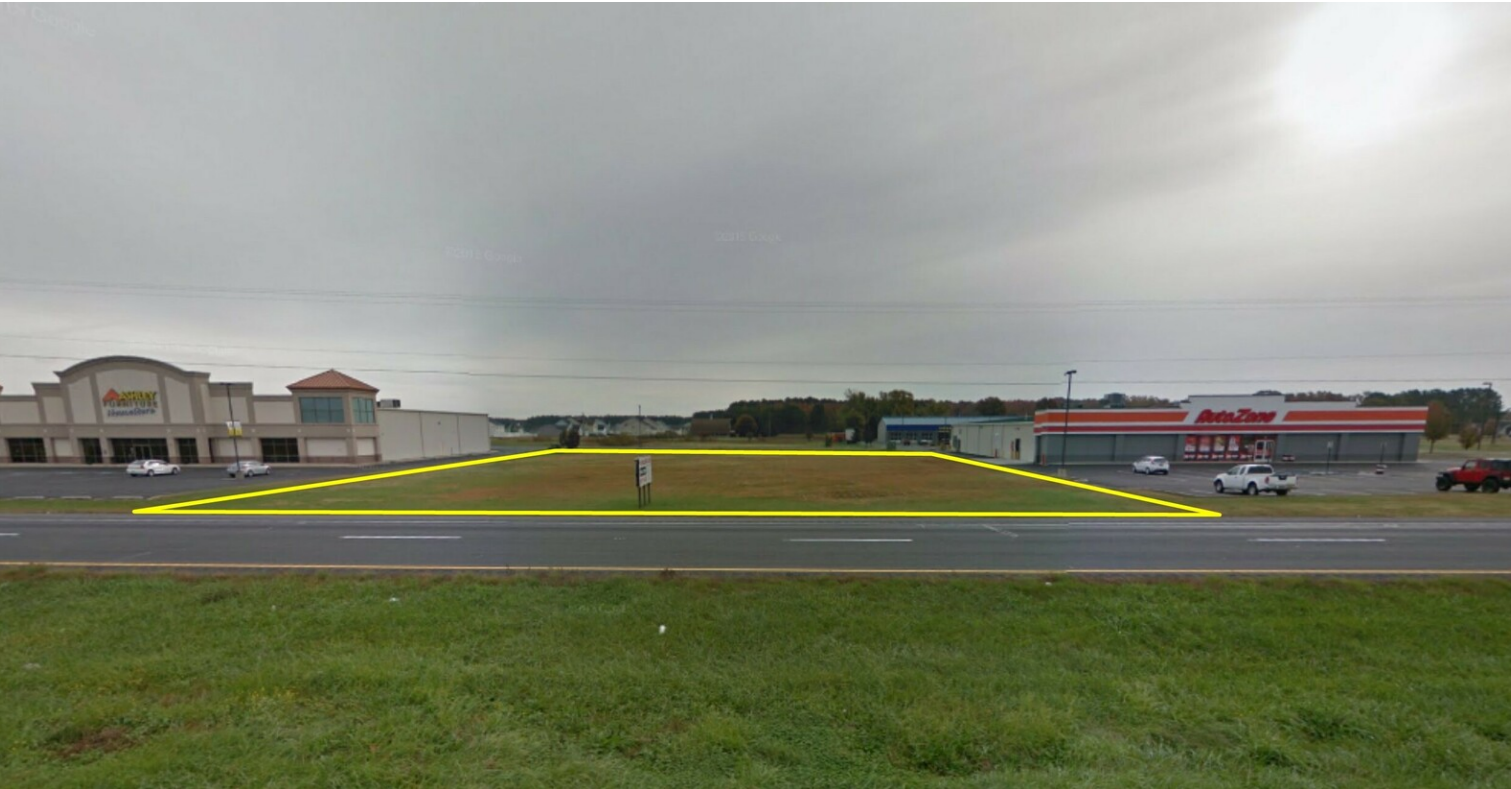

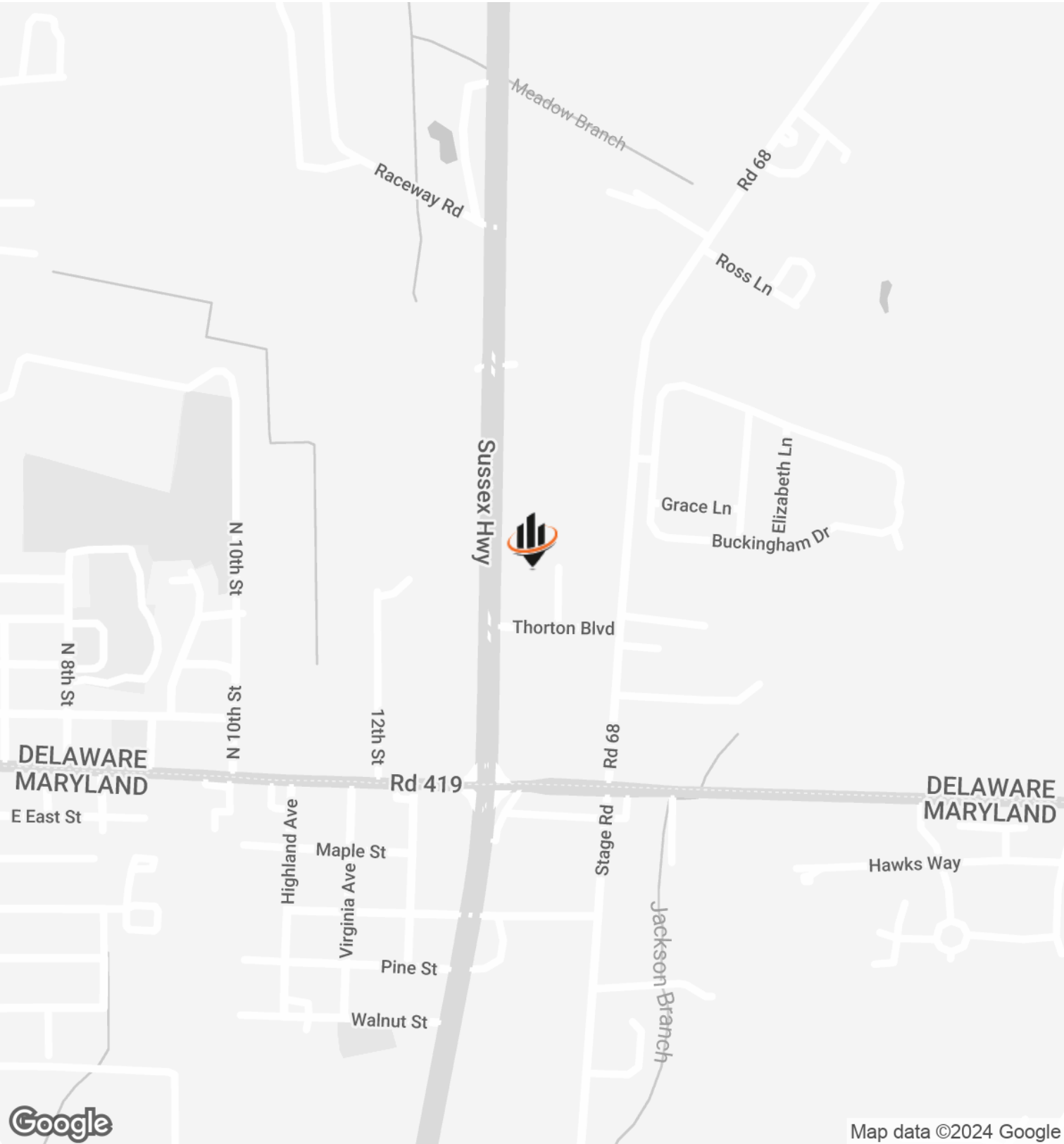

LOCATION MAP



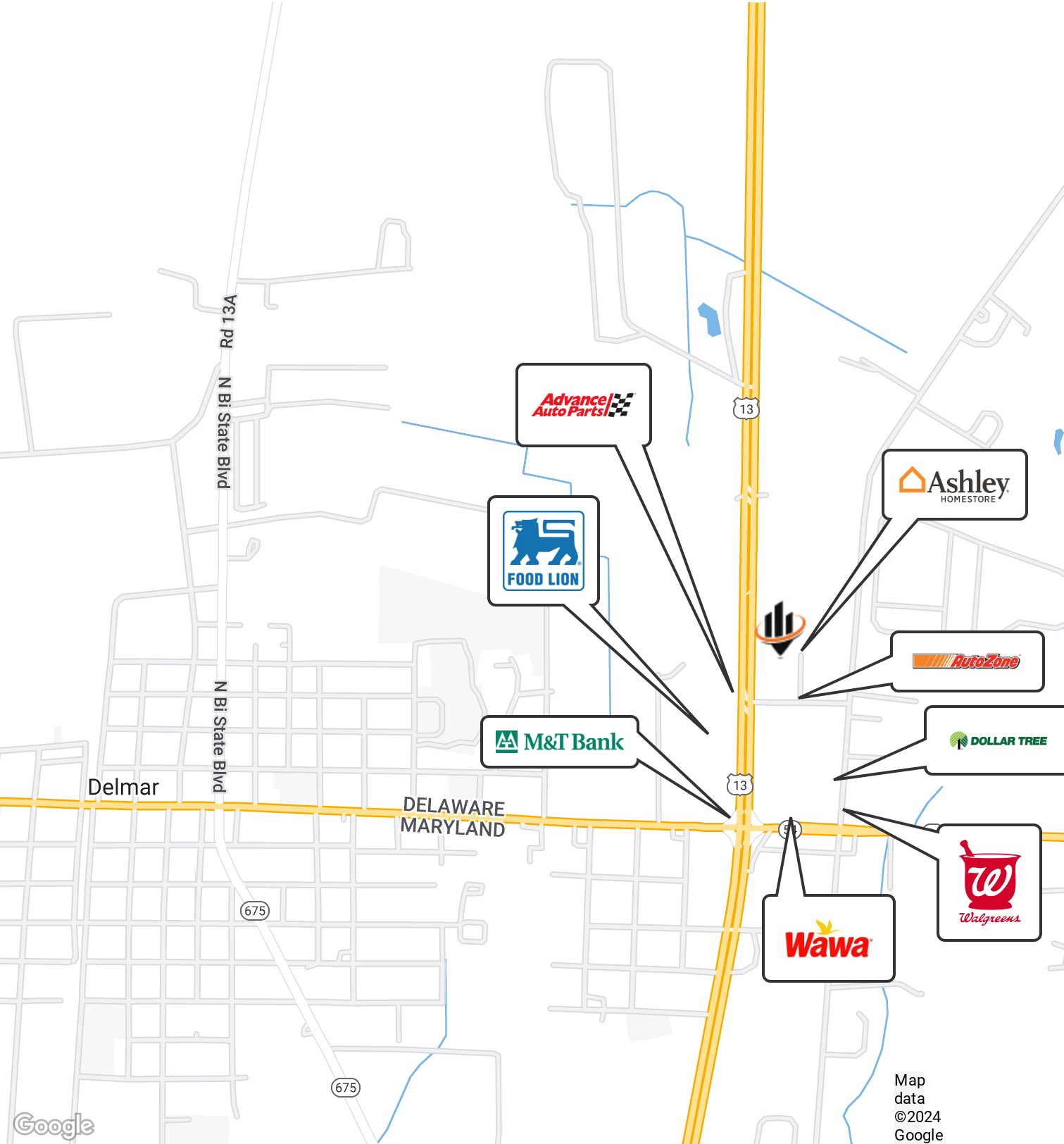
