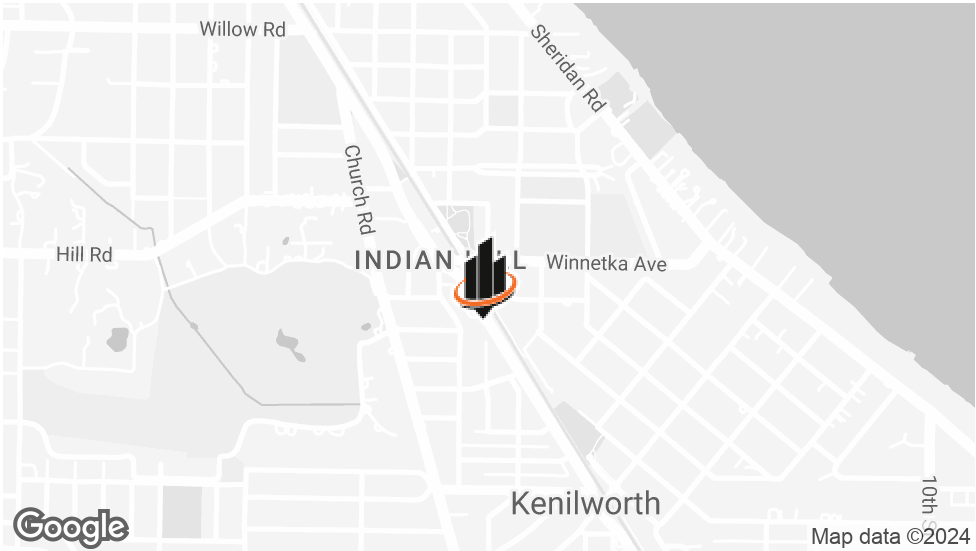

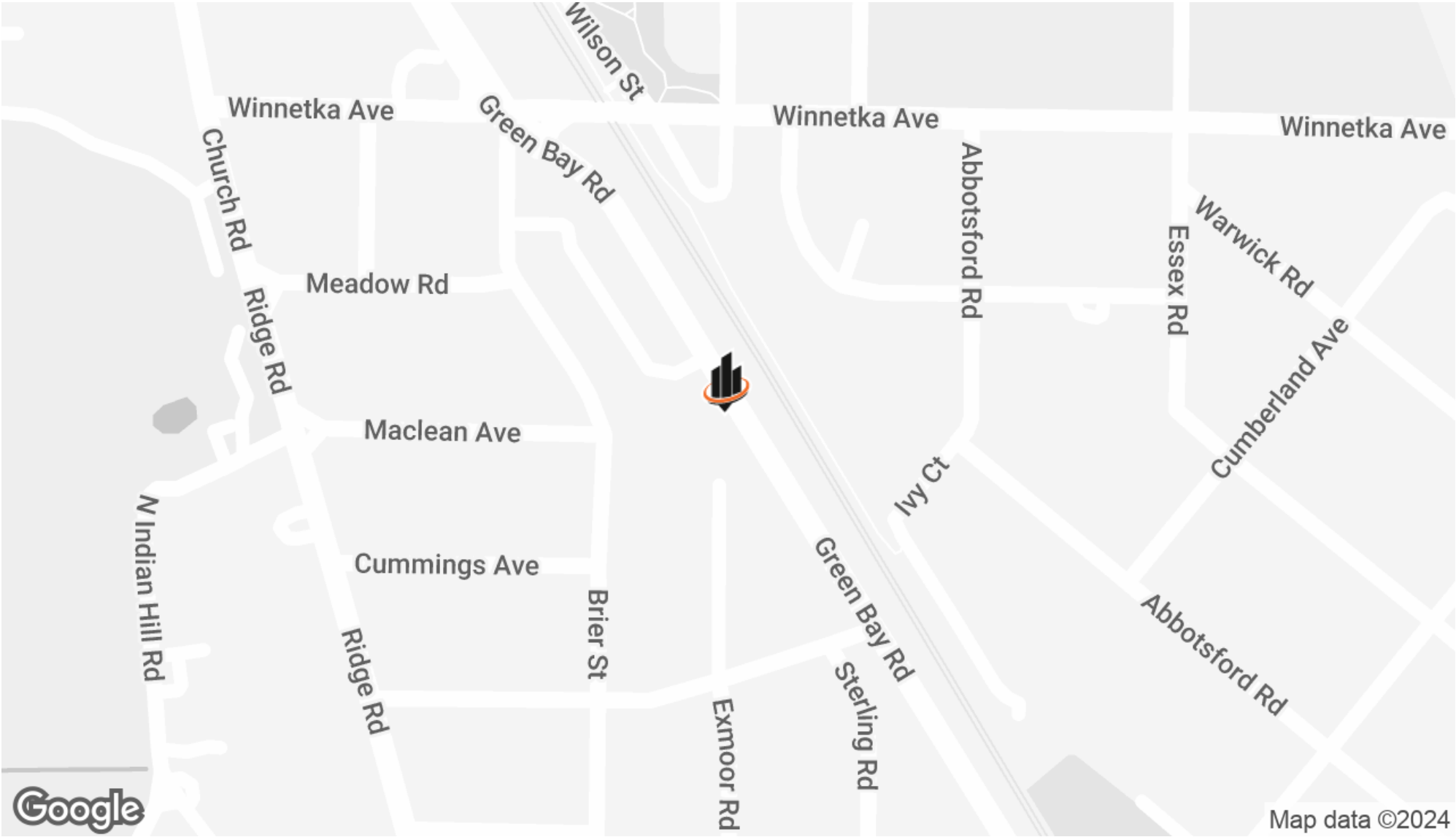

LOCATION MAP



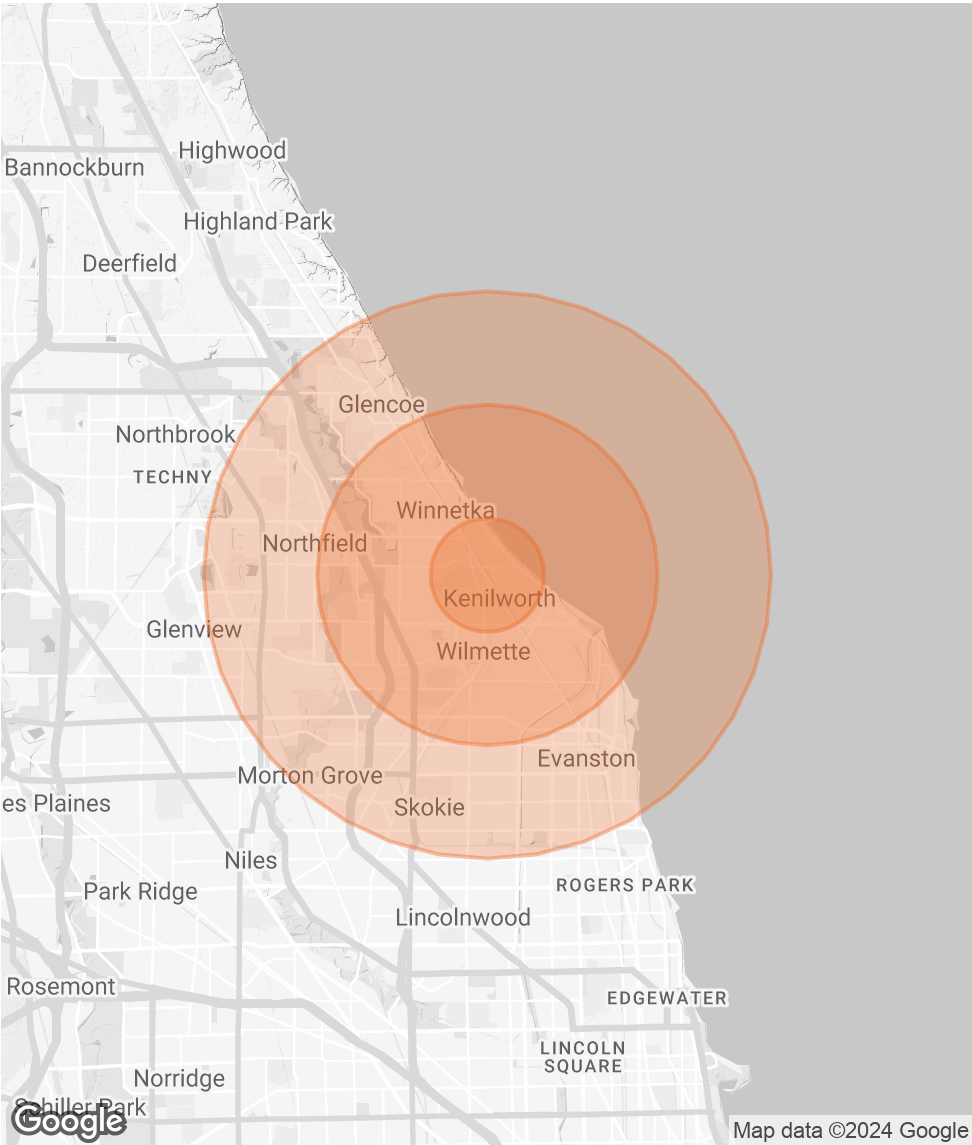
