GIS, two different soils on property, described as "Baymeade & Tohunta" soil series. The property has a low/flat linear sloping landscape positions front to back, that become more depressional in elevation.

With that said, the Baymeade soil series normally is on much higher topography/elevation, which does not describe your site or soils. The Tohunta soil series is what best describes your site in respect to Soil Wetness Conditions and soil characteristics. Which is Unsuitable in respect to SWC and a Septic System.

However, I focus all of my soil auger test holes within 100 'of front property line and all the way across property. This area is where the vegetation undergrowth was cut and bushhogged on property.
