

There are larger kennels to accommodate larger double boarders and giant breeds. They have access to both inside and out from 7 am til 9 pm. At night all dogs are brought inside to minimize noise in the residential area we are set in. All cats have an individual space, 4'x4' with a built in scratching post and window seat. Free exercise for dogs is done individually with a staff member- no pet is left unattended while out to run.

LOCATION MAP


