PROPERTY DESCRIPTION

This facility has been operated as a personal care facility for over 20 years. The site consists of three buildings estimated to be 3,026 square feet each. Buildings are ADA compliant, sprinklered, and laid out for wheelchair access throughout. Site has been approved by Columbia County for a fourth building that was never built. The facility operates under a very special zoning that allows for personal care homes for severely physically handicapped individuals or people with developmental disabilities. The property is approved for between 6 and 11 individuals per building per the county zoning records. Site is 3.31 acres.

The current operator has been in place for ten years and recently vacated at the end of the lease period. Property is also available for sale.

LOCATION DESCRIPTION

Property is located in Columbia County off Washington Rd in Martinez. Site is situated behind Club Car with frontage on Marshall St. The area is residential on three sides with a seasoned neighborhood. Site is near I-520 & I-20 with easy access to Richmond County and other major thoroughfares in the area. There is close access to shopping and dining as well as other amenities including the Evans Towne Center Park and Columbia County library.

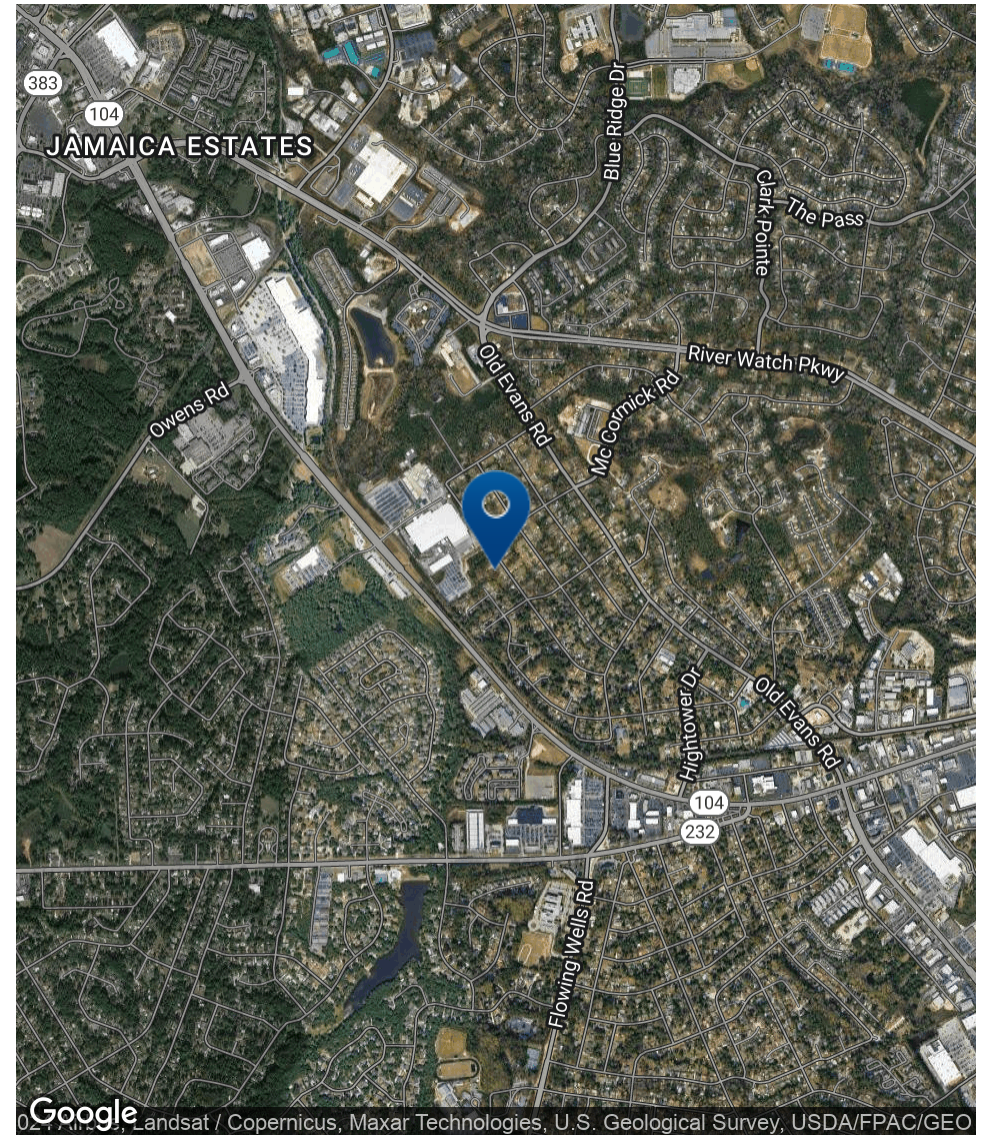
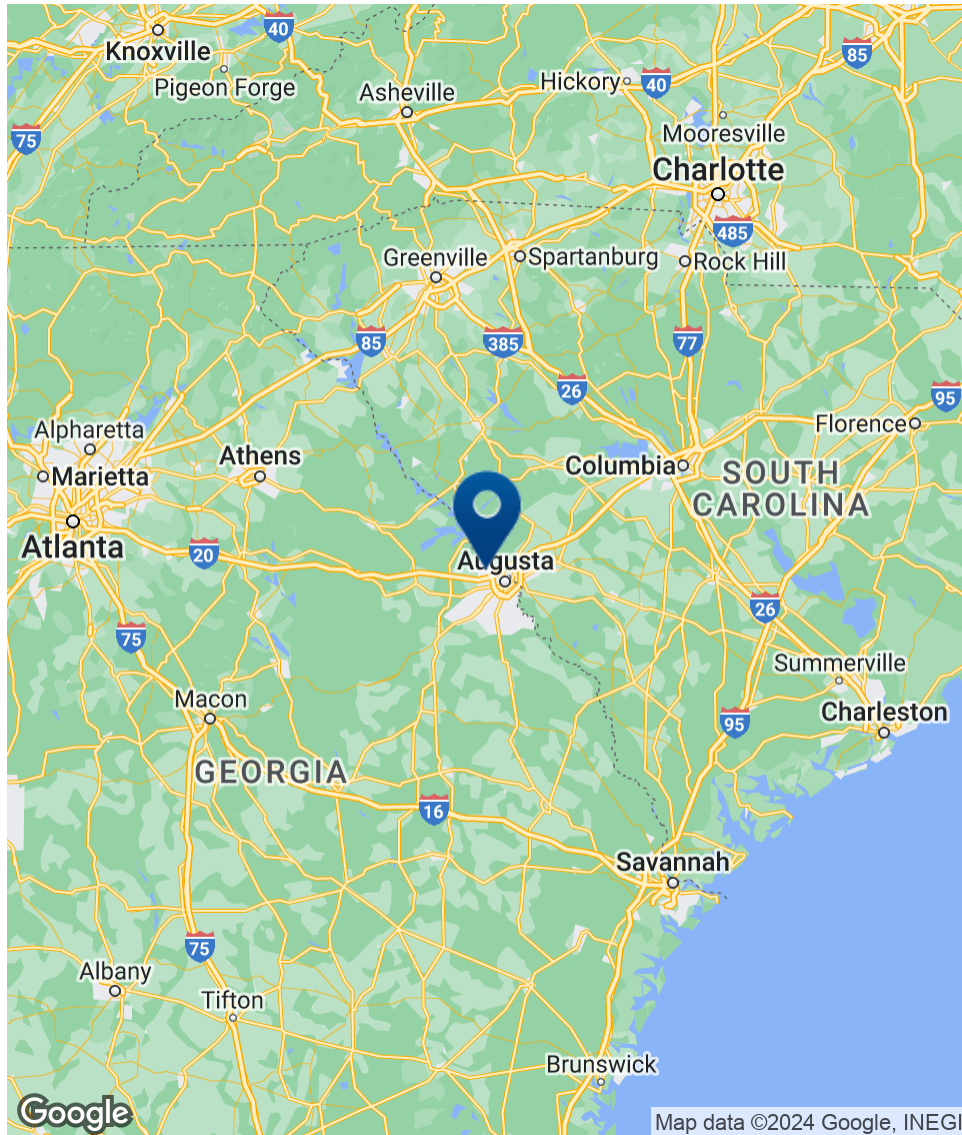

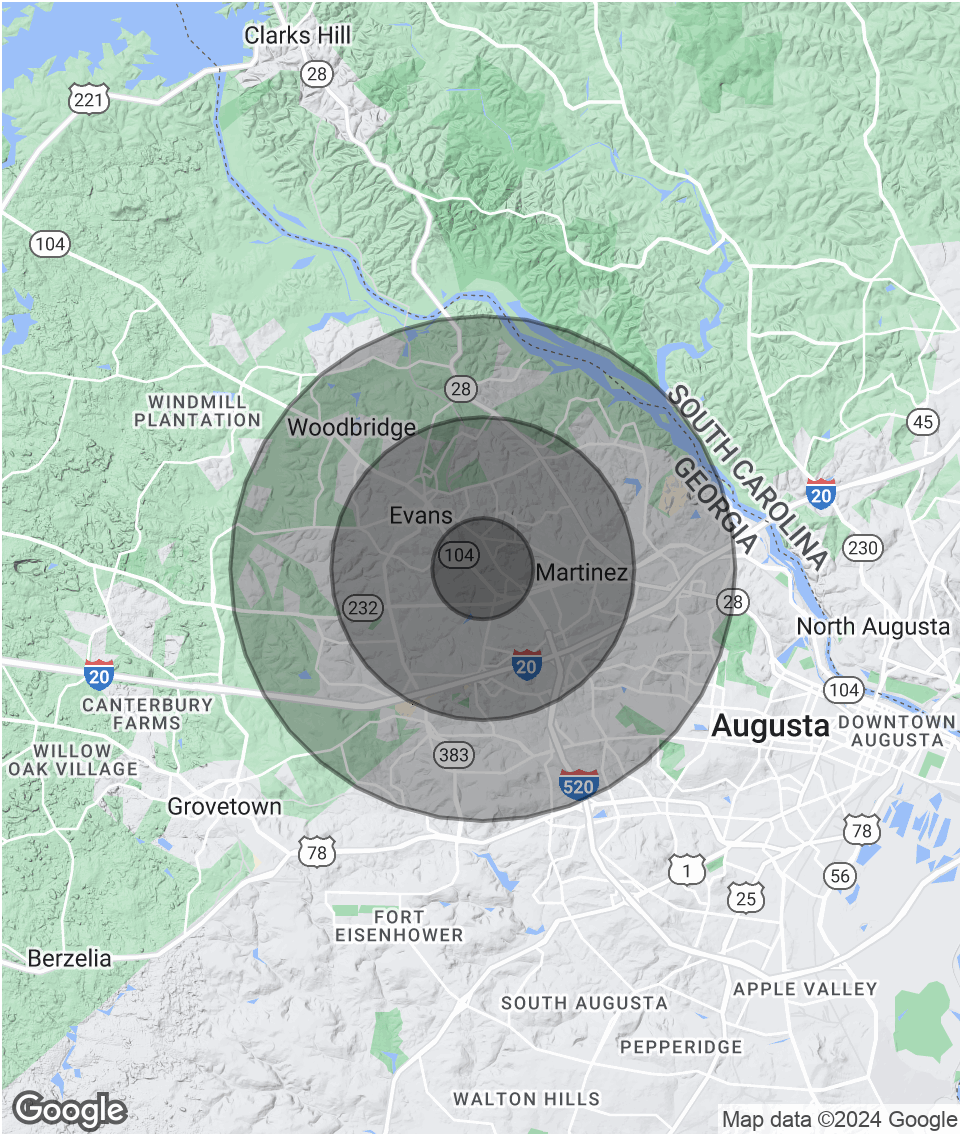
