Currently, 53.0% of the 17,041 housing units in the area are owner occupied; 24.9%, renter occupied; and 22.1% are vacant. Currently, in the U.S., 58.5% of the housing units in the area are owner occupied; 31.7% are renter occupied; and 9.8% are vacant. In 2020, there were 16,628 housing units in the area and 21.7% vacant housing units. The annual rate of change in housing units since 2020 is 0.76%. Median home value in the area is \$167,235, compared to a median home value of \$308,943 for the U.S. In five years, median value is projected to change by 1.34% annually to \$178,740.
