4531 Pigg Mattox Road has a total of six turkey/poultry houses across the +/- 25.68 acre premises. Two structures span 20,000 square feet each, while the remaining four spans roughly 16,000 square feet each. Each turkey house includes new cool pads for climate control and upgraded feed bins to streamline feeding processes.

In addition to the turkey houses, the property includes several pole buildings and lean-tos, offering a total of over 9,000 square feet of additional coverage.

Included with the property are essential farm assets, such as a tractor complete with tiller and spreader – essential tools for maintaining the land and ensuring smooth farming operations. Additionally, two 25 KW diesel generators stand ready to provide reliable power backup, ensuring uninterrupted workflow even during unforeseen circumstances.




