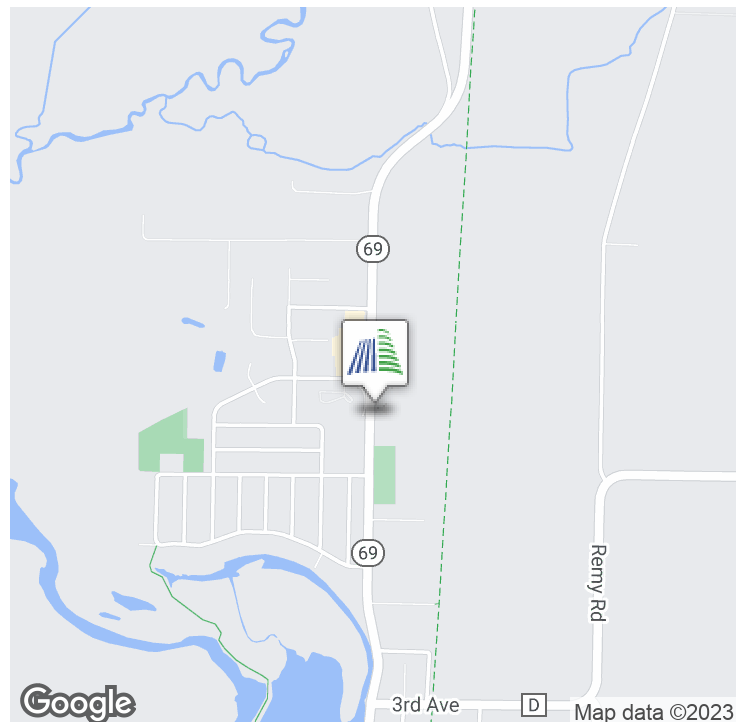

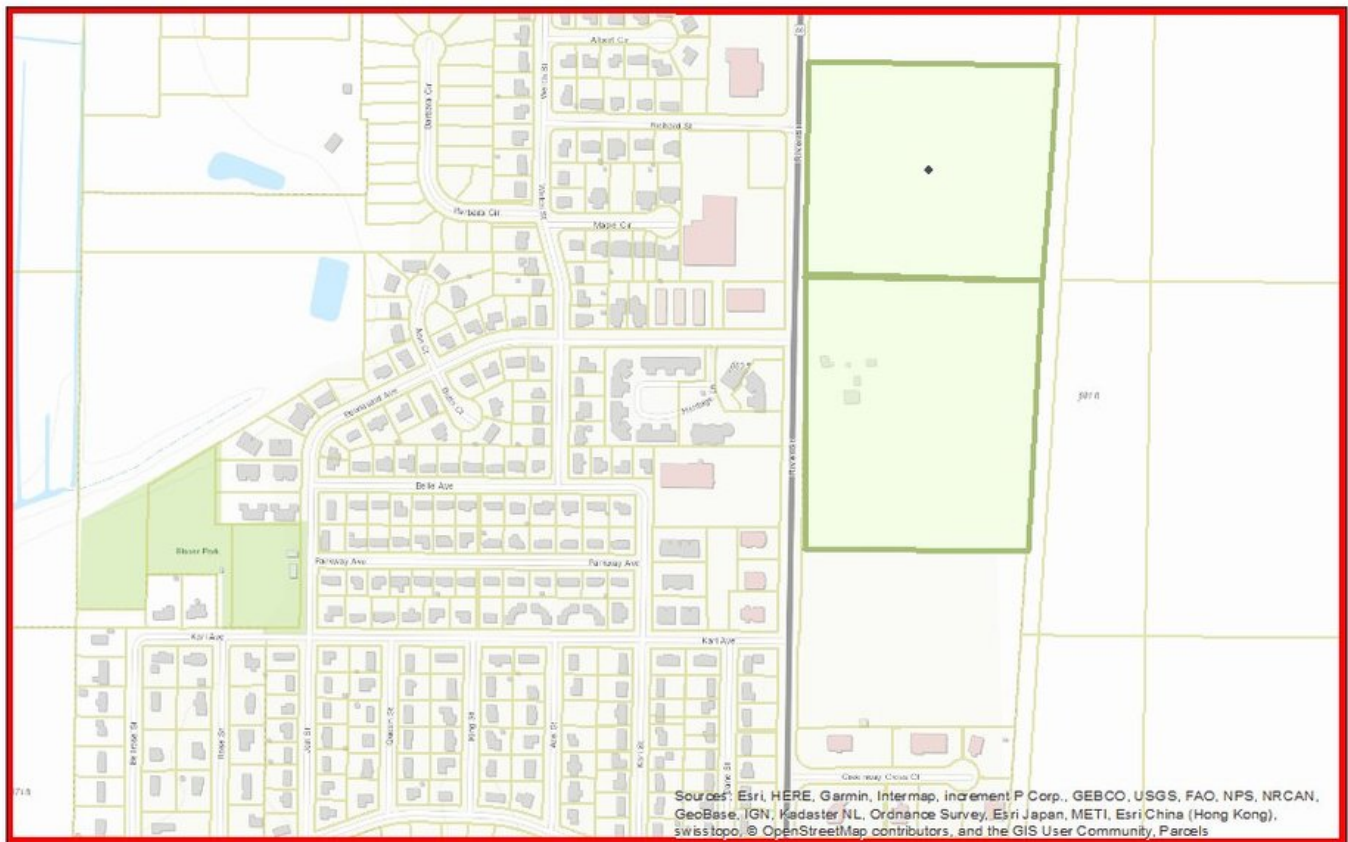

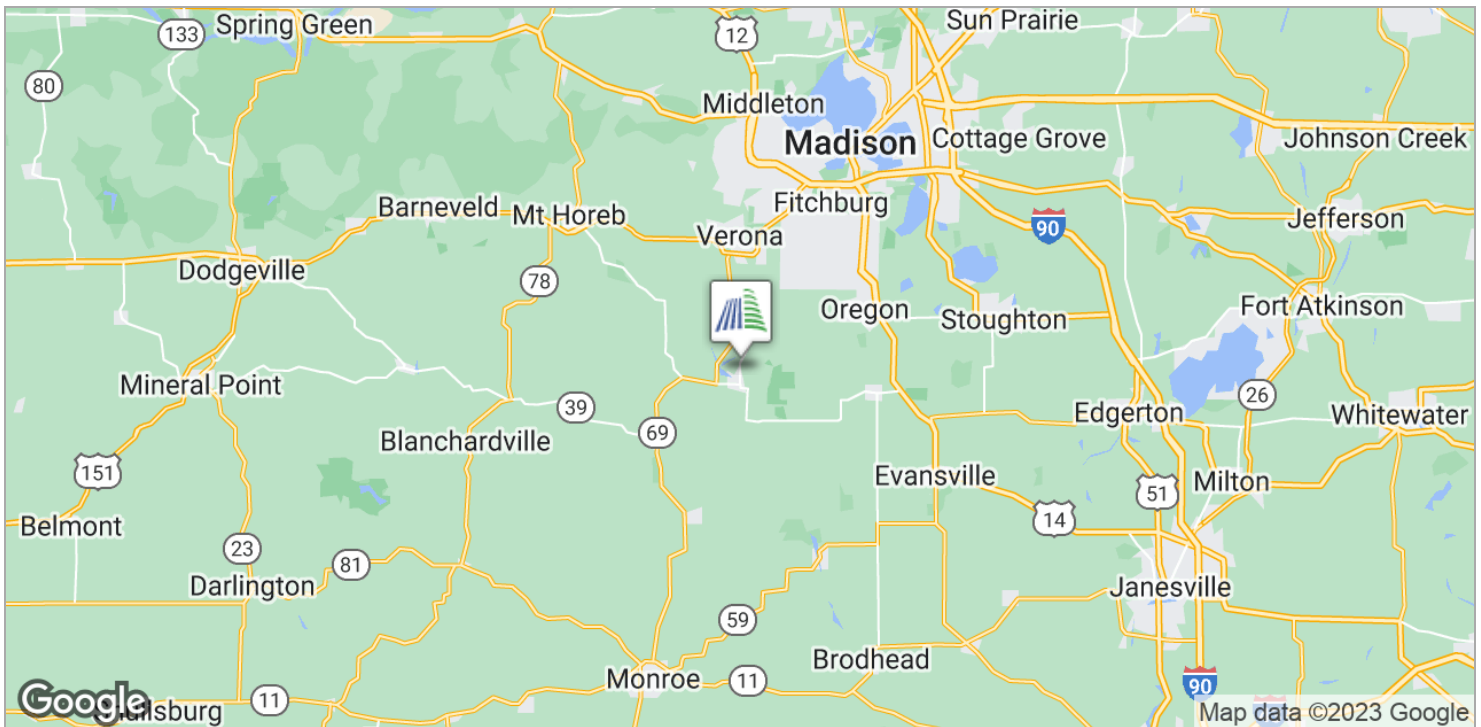

// LOCATION MAPS

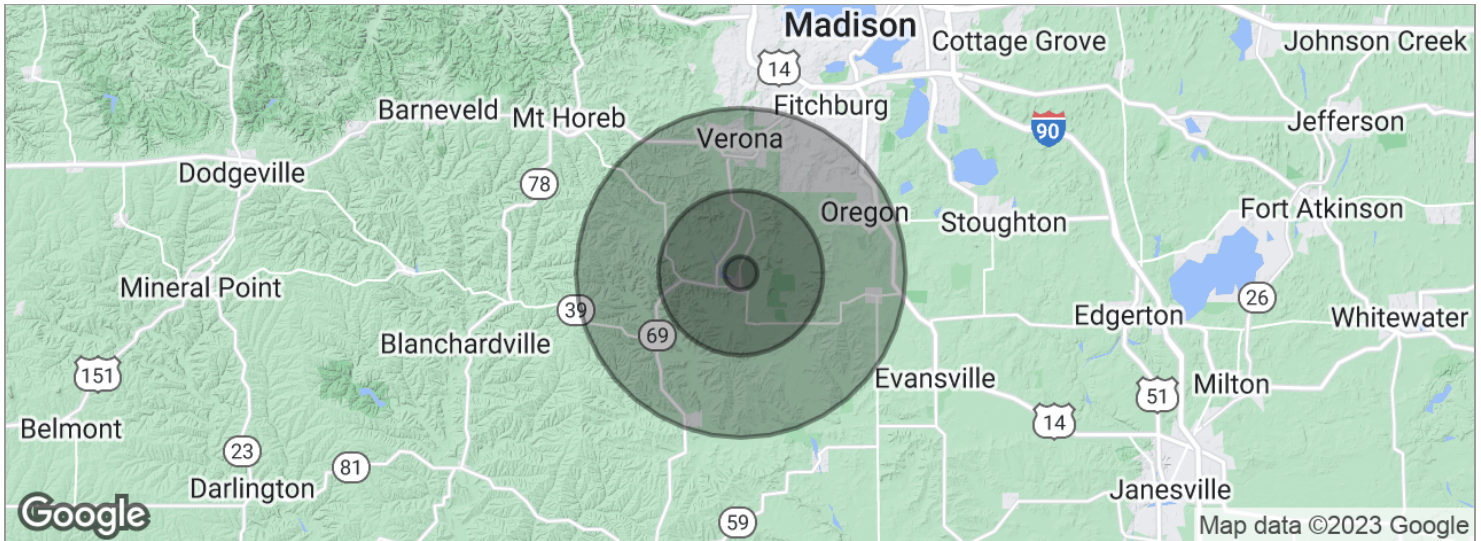
